Alice (35 years old) administrative worker, single mother with three children

- Alice works at the tax office, manages the taxpayer agenda and conducts audits.
- She has two children with her ex-husband, who left her when he found out she was pregnant with a third child with a "casual acquaintance".
- She tries to learn from her mistakes, takes exemplary care of her children, her whole life revolves around them and even though she has to save a lot, she tries to do her best for them.
- Alice's parents are no longer alive, so in her case there is no one to take care of the youngest child, the siblings would probably be separated, as the older ones would be taken in by their father and the youngest child would end up in an orphanage.



Barbara (42 years old) -successful businesswoman, single without family

- Barbara went through several relationships in her life, all of them were a disaster, that's why she is now single and has no children, there was no one to have them with.
- She had already accepted that she probably wouldn't start a family, so she decided to fulfill her otherwise.
- She has a successful business designing and selling sustainable fashion. She owns a small Ltd. with ten employees, the company is thriving, but Barbora has never groomed a successor to take over the business from her; with her death, the company would probably close and people would lose their jobs. It would also be the end of Barbara's clothing brand.
- Barbara donates part of the profits each year to her foundation, which supports conservation-oriented projects, and this foundation would also probably cease to exist after Barbara's death.



Charles (27 years old) promising artist, living in a registered partnership

- Charles and his partner have recently taken out a mortgage on their own flat and would very much like to adopt a child, but this is very problematic.
- Charles has already had several successful shows, including abroad.
- He teaches part-time at the Primary School and encourages children's love of art and develops their imagination.
- His own work focuses on human rights and discrimination, mainly focusing on LGBT issues, gender and racial discrimination.
- His works are often very controversial and shocking, which stimulates public debate.
- He has already achieved partial success by teaming up with human rights lobbying organisations and together they have managed to contact politicians and sway them to their ideas.



Daniel (61 years old) experienced neurosurgeon, married, one teenage daughter

- Daniel is happily married to his partner 20 years his junior, with whom he has a daughter who will graduate this year and is going to study medicine like her father, thanks to his high income he can afford a foreign university.
- Daniel's wife is a housewife, they met when she was at university, she did not finish school and never worked, she only cared for the warmth of the home. Should Daniel die, she will live off their joint savings for a while, but otherwise she has a big problem because she can hardly find a job to support her expensive lifestyle and her daughter's studies.
- Daniel is a top in his field, one of the best specialists in the country and has been asked to operate on complicated cases abroad more than once. He has saved the lives of many people who had minimal chance of survival and are now living full lives. He is totally dedicated to his mission and as long as his health serves him, he intends to continue to devote himself to it long after he reaches retirement age.



Elia (17 years old) a talented student originally from Syria, an orphan living in a foster family,

- Elia's journey has been a harrowing one, her parents gave all their money to smugglers to get her to Europe. Unfortunately, Elia could never tell them that she actually made it to Europe because before she could, her parents were killed in a bombing raid.
- Now Elia lives with a foster family, is improving her Czech very quickly and has excellent academic results. She won the national round in the Chemistry Olympiad, is already actively involved in other scientific projects and would like to study pharmacy and participate in the search for cures for now incurable diseases.
- At the same time, she is a very complicated person, and has difficulty getting along with people due to cultural differences and traumatic childhood experiences. Her foster parents try to support her in every way they can because they see her as a brilliant child, but they are afraid that she will waste her talent.



Frank (55 years old) janitor, divorced due to alcohol problems, two adult children

- Frank had a very difficult life, he was once married and worked as an electrician. But then his eldest son died in a car accident and Frank couldn't bear it. He started drinking, he got into debt and the family ended up in foreclosure.
- His wife divorced him and raised their daughters alone, though it was hard. The daughters refuse to see their father.
- Due to alcohol and foreclosures, Frank spent several years homeless. But then, with the help of social workers, he pulled himself together, underwent treatment and found a job. Today he is a janitor, lives in a cheap sublet and lives a decent life; anyone who doesn't know him wouldn't know what he's been through.
- In his spare time, he does awareness talks in schools, low-income facilities and other social organizations because he believes his story is very enlightening and if he shares it, it will prevent other people from getting into similar problems.
