  - traditionally democratic country;
  - parliamentary democracy;
  - presidential system;
  - election preferences are traditionally divided between Socialists and Republicans.

  - Population: cca 66 mil.;
  - Religions (cca):
    - 60 % Christianity;
    - 4.5 % Islam;
    - 0.5 % Judaism;
    - 1.5 % Hinduism;
    - 33.5 % Atheism/other.



# 8.1 Economic Indicators of Significant Countries

## United Kingdom:

- Demographic information
  - Nationality: 83.9% English;  
8.4% Scottish;  
4.8% Welsh;  
2.9% Irish (who are part of the United Kingdom).

# 8.1 Economic Indicators of Significant Countries

## United Kingdom:

- Political system
  - traditionally democratic country;
  - constitutional monarchy - Queen Elizabeth II is the head of the state since 1952. (therewithal the formal head of government and jurisdiction, the head of the Anglican Church and the Supreme Commander of all the UK Armed Forces);
  - prime minister system;
  - two chambers parliament: House of Commons and House of Lords;
  - election preferences are traditionally divided between Liberals and Conservatives.
